## Portfolio Management

The Fund portfolio is managed by a veteran investment team with 71 years collective investment experience. The team maintains a disciplined focus by integrating a very similar portfolio construction process used with Emerald's small cap growth portfolios developed in 1992. As a result of an on-going comprehensive risk assessment process the team seeks to control volatility by diversifying the Fund's portfolio among subgroups within each industry sector and seeks to minimize risk by unequally weighting the percentage ownership of companies held.

Diversification does not eliminate the risk of experiencing investment losses.

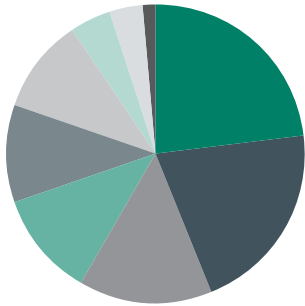
## Objective

The Fund seeks long-term growth through capital appreciation.

The Fund invests in companies of any size and favors mid-capitalization companies with market capitalization equal to or less than the largest company in the Russell Mid Cap Growth Index and seeks companies with perceived leadership positions and competitive advantages. The portfolio is diversified across industry sectors and includes companies that do not receive significant coverage from other institutional investors.

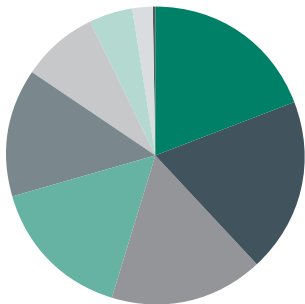

The Adviser may not discontinue this waiver, prior to August 31, 2017, without the approval by the Fund's Board of Trustees.
